# 1 Housekeeping

In the absence of Arina Motova, Sébastien Metz is appointed rapporteur of the General Assembly.

Nineteen (19) members of the association signed the attendance list (see Annexe 1), which means that the attendance exceeds the quorum (10).

# 2 President's report

Leyre Goti (outgoing president) presents the president's report.

### 2.1 The 2025 Conference

The 2025 EAFE conference is the 26<sup>th</sup> conference organised by the association since its inception in 1989. The 2025 conference is however the first in the history of the association to be directly organised by the Bureau, with a special mention of Monica Gambino, who coordinated all the efforts in Rome, with the help of Sébastien Metz who developed all the websites and platforms needed for the conference (the conference website, the abstract submission platform and the ticketing platform). The conference wouldn't have been possible without the support of the National Research Council of Italy (CNR). We also have two special sessions; one supported by the European Commission (DG Mare) and one by FAO.

This in-house conference organisation demonstrates the maturity of the association, as well as its willingness to overcome complex situations. Overall, it seems that the 2025 conference will be more successful than the 2023 conference, with higher attendance.

#### 2.2 Evolution of the association

Leyre notes that the landscape in which operates EAFE is shifting, which may pose a challenge to the association. When the association was created (1989), the European Union had 12 members and Germany wasn't reunited. Now the association has members from all the EU including neighbouring countries: UK, Iceland, Norway, Faroe or Turkey.

There are now more women entering the profession of fisheries economists, which should be reflected in future Bureaus, by reinforcing potentially rules about parity. More women are attending the conference, but also more NGOS, more young researchers, more freelance economists, more researchers from the private sector. Researchers are embracing more the interdisciplinary approaches.

In the future, the association will need to integrate all these collectives to exploit to the maximum its leveraging and support capacity.

## 2.3 Change of the legal address of the association

Leyre Goti reminds the assembly the difficulties to operate an international association, with members scattered across Europe, from Iceland to Turkey. There is currently no legal framework to establish an EU association. EAFE is registered in France, but there is a need to relocate the association's official address for practical reasons.

The association was initially registered in Paris, but since its inception in 1989, most fisheries economists working in France have relocated to Brest and Quimper. There is a strong academic presence, with the UMR Amure combining staff from the UBO (University of Brest) and IFREMER. There are also researchers working for the private sector located in or close to Brest (notably Sakana Consultants).

In the meantime, there are currently no association members located in Paris, nor any academic team that would potentially join the association in the short to medium term.

It is therefore considered more practical by the association bureau to move the registration address to Brest.

The Bureau requests authorisation from the General Assembly to search for a new registration address in Brest (see Section 6.1, "New Address").

The General Assembly authorises the Bureau to search for a new registration address.

# 3 Treasurer's report

Hans van Oostenbrugge (outgoing Treasurer) presents the Treasurer's report.

This report combines the financial overview of the years 2023 to 2024.

## 3.1 Overview of receipts and expenditures for the period 2023-2024

Table 1 summarises key figures.

The balance of the association accounts was € 47 749,90 as of December 31, 2022.

Over the period 2023-2024, the key incomes of the association were:

- € 2 650,00 from membership fees and
- € 420,38 as interest.

The key expenses were:

- € 241,65 on bank costs and
- € 0.00 on additional operating costs. These operational costs were low, as all bureau meetings were held online and no bureau member claimed any travel costs. No expenses were paid for the website during the period.

Due to the lower-than-expected attendance at the Athens conference, the conference resulted in a net deficit of €6 037,00.

As a result, the balance of the association accounts has decreased by  $\[ \le \]$  208,47 over the 2023-2024 period, with a total of  $\[ \le \]$  44 541,63 as of December 31, 2024.

## 3.2 Membership evolution

Membership for 2023 and 2024 remained stable at 35 members. The number of persons involved in these memberships increased to 47 persons:

- Individual members (23)
- Students (7)
- Corporate (5, including 17 persons)
- Associate (0)

In 2018, the Bureau decided that the Membership fee would be collected with the conference fee, as this was seen as more convenient for the members. However, this has resulted in a considerable decline in membership. From 2022 onwards, membership has been slowly increasing, and the number of institutional members has also increased recently. The income from these memberships has been paid only in 2025. As of 2025, the following organisations are institutional members:

### 3.3 Prospect for 2025-2026

As for 2025, the financial position of EAFE is likely to strengthen, as the projected costs for the Rome conference are lower than those for the 2023 conference. This stronger position is mainly due to the 2023 conference being organised by an external company and hosted in a hotel in the centre of Athens. The association savings partly compensated the deficit generated. In comparison, the organisation of the 2025 conference is expected to create a surplus, as 1) no external company was hired for the organisation, and 2) the conference was hosted by CNR, which limited the costs incurred for the conference's organisation.

## 3.4 Validation of the Treasurer's report

# 5 Any other business

## 5.1 Pavel Salz: discussion on EAFE online workshops

Pavel Salz introduces the rationale of his proposal.

The association should expand its wings to be in contact with more stakeholders. Pavel's suggestion involves organising regular online workshops, at least every three months. The process will be participatory, with association members proposing issues for discussion. Organising this online is seen as a low-resource option that doesn't need a lot of time to organise. With a planning phase of 6 to 9 months, this would allow enough communication to raise awareness and maintain engagement without overloading participants.

Pavel mentions he had organised a CFP reform group on LinkedIn, but the initiative didn't last.

Pavel already has 5-6 ideas that could each be covered in 2-3 hours:

- We are in an interesting moment in time: the CFP review is ongoing. This topic could allow the association to contribute to this critical discussion.
- The long-term outlook of EU fisheries
- The competition with other uses: wind farms, Natural 2000
- Is there a market failure? In fisheries management, but also close domains
- Policy efficiency from an economic perspective
- Bottom trawling in MPAs and elsewhere

A general discussion follows Pavel's proposal, key points to be noted are:

- An overall agreement that this kind of activity could revitalise the association and facilitate improved discussions between EAFE members.
- The landscape has changed online. Many organisations do regular webinars; The association needs to differentiate its offer.
- There are opportunities to connect with other organisations, such as ICES Brest 2026 (September).

Pavel offers to draft a first concept note detailing the process and the intention to be submitted to the Bureau at the end of the summer, to allow
